Please note that the cutoff date to make your reservations is **February 2, 2024.**

Reservations can also be made by using one of these following steps:

- **Phone: toll free by calling 1-888-HOLIDAY, or by contacting the hotel directly at 435- 628-8007. Confirmations will be emailed once reservations have been made.**
- If you would like to make a room reservation for a date different from the date(s) in the block-please call. Extra rooms before or after your group's block may or may not be available and may be a different rate. We will advise you on room availability and room rates when you call.

**Payment methods and information:**

- ***Tax Exempt:***  
*The State of Utah requires that all taxes are run through the Utah state tax office. Tax exempt entities recognized by the State of Utah may still be eligible for tax exempt status for hotel stays but they will be required to pay taxes at the hotel and then file a Petition for Redetermination (form TC-738) for a refund claim. The Holiday Inn St. George Convention Center will not be able to give tax exemption on State or Local taxes for individuals due to this new mandate. Government ID will be required to authorize government per diem rates.*
- We accept the following credit cards: Visa, MasterCard, Discover, and American Express. *\*\*Special arrangements through the hotel will be needed if you will be paying with a Business Check.*
- **There are only 40 rooms reserved for conference attendees and may be at different hotel locations: Holiday Inn, Fairfield Inn, Hilton Garden Inn, and Hyatt Place.**
- Please note that the cutoff date to make your reservations is **February 2, 2024.**
- If you have any other special interests or requests, please let us know at this time.
- **A 48-hour cancellation notice applies to all individuals.**
- When you arrive at the hotel for your group event, please check into your room at the hotel front desk. To help with this process please provide the front desk clerk with the following:
  1. Photo Identification
  2. A credit card for room incidentals or a \$50.00 cash deposit may be required. (Charges to your room are from using room amenities such as Pay-per-view movies, telephone, video games, etc. If you do not use any of these amenities your room bill will not be charged.)
